"Antitrust implications of patent settlements"

Donald Baker was Assistant Attorney General in charge of the Antitrust Division (1976-1977), having previously been a member of the career staff in the Division, including a period as Trial Attorney and Section Chief. He then entered private practice as a Washington partner of two major law firms (1978-1994) before establishing an independent practice in Washington specializing in antitrust and competition policy issues. He has served as an expert witness on relief in the *Microsoft* case before the District Court and on intellectual property antitrust issues in several litigation/arbitration proceedings. He will explain and discuss the continuing developments in the United States in this topical area, in particular the debate over reverse payments exemplified in the *Schering-Plough* and *Tamoxifen* cases.
